The hub height remains unchanged at a maximum height of 85m. Total maximum turbine tip height increase from 126.5m to 131m (Figure 1.3)

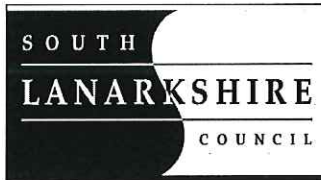
